ALL HORSES ENTERED IN CLAIMING RACES MUST HAVE CLAIMING AUTHORIZATIONS ON FILE IN THE RACE OFFICE OR THEY WILL NOT BE PERMITTED TO RACE.

CLAIMING ALLOWANCES 4YO MARES 50%, 3YO FILLIES 70%, AGED MARES 20%, 4YO H&G 30% 3YO C&G 50%

TRAINERS ARE RESPONSIBLE FOR CHECKING ON THE AVAILABILITY OF THE DRIVERS THEY HAVE LISTED.

HORSES WILL ONLY BE ALLOWED TO DROP ONE CLASS AT A TIME FROM THEIR PREVIOUS MAINE START UNLESS APPROVED BY THE RACE SECRETARY.

CLASSES MAY BE COMBINED TO FILL A RACE.

WINNING HORSES MAY BE ADVANCED IN CLASS REGARDLESS OF EARNINGS.

HORSES TRANSFERRED TO A SECOND CHOICE EVENT WILL LOSE PREFERENCE TO THOSE ALREADY ENTERED AND ELIGIBLE TO THE EVENT, UNLESS THE ORIGINAL EVENT DID NOT FILL.

ATTENTION HORSEMEN: DUE TO INSURANCE REASONS NO ONE WILL BE ALLOWED ON THE RACE TRACK EITHER JOGGING, TRAINING, WARMING UP OR RACING HORSES WITHOUT A HELMET SECURELY FASTENED.
